# Beacon Sloop Club General Meeting

Minutes, November 6, 2015

Opening Song: "It Takes a Worried Man"

James welcomed back Saul, who was at tonight's meeting.

Treasury: Opening balance \$220,361 and closing balance \$225,060. Now is a good time to renew your membership.

Nominations: Betty Harkins presented the committee's slate:

Alan Thomas made a motion to accept the slate. It was accepted. Then we had nominations from the floor:

President: Steve Schwartz – he accepted

Vice President: Steve Schwartz – he accepted

Secretary: Steve Schwartz – he declined; Joyce Hanson – she accepted

Treasurer: Steve Schwartz – he declined

We thanked the Nominating Committee.

Firewood: Some sources are available for free firewood for the clubhouse but we need a volunteer with a truck and others to get it here. A sign-up sheet was sent around.

Woody Report: Don Raskopf said work is ongoing. All shear planks have been replaced. Other work includes, stringers, planks & sisters. About 80% of the lumber needed has been donated. This along with the volunteer hours is saving us money and time. Work is also going on to winterize the shed for the Woody by putting tenting up to make work possible. Kricker's crew will now be focusing on the Clearwater, which arrived this week, through their spring launch. Winter work will continue but at a slower pace. Wayne Ford will give a workshop on frame replacement on November 15 from 10 – 2 at the boat. He will work with club volunteers to teach the process of removing old frames, as well as fabricating and installing new ones. It is important to be there if you plan to work over the winter. The training will be followed by a work party. Steve Schwartz said that White's Marina said our Mast and Boom can stay there. The boom needs to be oiled and covered with plastic.

Funding: The response to the Appeal Letter sent to current and past members has yielded \$4000 so far. In response to a question Alan said there are also several outstanding grants that have been applied for – Hudson River Improvement Fund, Patagonia, Hudson Valley Community Fund (for docks), and NYS Arts, Culture and Heritage. We hope to hear the results of the Improvement Fund soon. We are looking into applying to the DEC Estuary Program. Alan prepared a package that can be sent out to the donors that comprise the Community Fund. The Grants committee is open to ideas and could use volunteers to refresh the queue. The Indiegogo social media site setup is in progress.

Solar Trailers: Sal Rosinsky reported a rain cover was lost and now hardware needs to be replaced on one of the trailers. The second was towed from the Festival before the ground wires were removed and suffered some damage.

### The Woody Guthrie Restoration



The Woody has been stabilized with the installation of new shear clamps, bilge stringers, and the new king plank as the professional shipwrights are shifting their attention to the Clearwater.

New odd upper frames have been fabricated and installed on both port and starboard along with new deck beams, and many other items.

We now have four of our volunteers who have learned to fabricate frames and Wayne Ford is giving a workshop this Sunday to continue our training and empower us to continue some of the skilled tasks over the winter. There are still many tasks for volunteers of all skill levels, clean up, organizing supplies, lending an extra hand, engaging the public, etc. etc. We will also need volunteers to winterize the shed. We are also discussing opportunities to work with Clearwater to free up the shipwrights sooner.

If we can raise the remaining funds over the winter we are well positioned to launch next year.

**EPA Statement on Approval of PCB Processing Facility Demobilization and Restoration Plan for Hudson River Cleanup, November 12, 2015**

After considering public input, the EPA has approved a plan that outlines the multi-step process General Electric (GE) will follow to dismantle and decontaminate the 110 acre PCB sediment processing facility that was built to support the dredging of the Hudson River PCBs Superfund Site. The plan, called the Processing Facility Demobilization and Restoration Plan, is required by the 2006 legal agreement between GE and the EPA for the dredging work. The EPA will oversee GE's performance of the work required by the plan.

With the sixth and final season of dredging now complete, the approval provides permission to GE to begin the demobilization and restoration process as outlined in the plan.

The demobilization process will continue into 2016. In general, the multi-step demobilization process includes:

- Decontamination of equipment and infrastructure (e.g. unloading equipment, buildings, concrete surfaces etc.)
- Sampling of equipment/materials
- Final placement of equipment/materials (e.g. sale, reuse, salvage/recycling, or off-site disposal)
- Environmental sampling (soil, groundwater, sediment and surface water)
- Property restoration

Backfilling of previously dredged areas with clean material was completed earlier this week. The processing facility will continue to load railcars until all dredged material has been transported off site, which is expected to occur by the end of the year.

The majority of comments received by the EPA on the draft demobilization and restoration plan focused on two central themes. Some commenters did not want the EPA to allow the demobilization to occur in case there is an opportunity for additional dredging. No such opportunity is imminent and should an agreement be struck by parties other than the EPA a temporary processing facility can be constructed. The EPA has used temporary dewatering facilities at other sites around the country. Dismantling the 100-acre plant would not preclude future dredging.

Other commenters requested that infrastructure be left in place to support future development of the site for the economic benefit of the municipalities and the surrounding area. It is anticipated that some buildings, concrete/asphalt roads and surfaces, the wharf and the rail yard will remain. The final determination on what will be left in place will depend on ongoing discussions among the parties (the EPA, GE, the property owners and the municipalities), the results of sampling, and the ability for the various components of the site to be decontaminated. The EPA has been informed that the Town and Village of Fort Edward are exploring opportunities for reuse of the site to support future economic development in the area.

**Statement on Hudson River Demobilization Plan  
U.S. Fish & Wildlife Service and NOAA  
Federal Hudson River Natural Resource Trustees  
November 12, 2015**

The Hudson River valley is a unique and nationally significant ecological, cultural and economic resource. Under Federal Superfund law, GE is responsible for both the remediation – cleanup – of the PCB contamination, and the restoration of injured natural resources through the Natural Resource Damage Assessment and Restoration process. Now is the time for GE to thoroughly address their PCB contamination of the Hudson River.

Although the dredging has removed some of the contamination, it has not addressed nor compensated the public for injuries to natural resources. Trustees have determined that GE's PCBs have injured groundwater, fish, waterfowl, surface water, and navigational services of the Hudson River for decades, and these injuries will continue well into the future. On behalf of the American people, including all New Yorkers, the Trustees will continue to vigorously pursue measures to ensure GE meets its obligations and to recover damages to restore the natural resources of the Hudson River.


